# A BILL

To amend the Omnibus Crime Control and Safe Streets Act of 1968 to require a certain percentage of COPS grant funds to be used for the salaries and benefits of school resource officers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “School Resource Offi-  
5 cer Act of 2019”.

6 **SEC. 2. SENSE OF CONGRESS.**

7 It is the sense of Congress that—

1           (1) a school resource officer program provides  
2           a safe learning environment in our Nation’s schools,  
3           provides valuable resources to school staff members,  
4           and fosters positive relationships between youth and  
5           law enforcement;

6           (2) school resource officers are educators, infor-  
7           mal counselors and mentors, and law enforcement  
8           officers;

9           (3) local agencies need the resources and flexi-  
10          bility to establish school resource officer programs  
11          that will encourage partnerships between schools and  
12          local law enforcement agencies to develop innovative  
13          ways to make schools safe; and

14          (4) Federal grants for school resource officer  
15          salaries are intended to be a starting point for con-  
16          tinued local action and should not divert current  
17          designated funding.

18 **SEC. 3. FUNDING FOR COPS IN SCHOOLS.**

19          (a) AUTHORIZATION OF APPROPRIATIONS.—Section  
20          1001(a)(11)(A) of the Omnibus Crime Control and Safe  
21          Streets Act of 1968 (34 U.S.C. 10261(a)(11)(A)) is  
22          amended by inserting before the period at the end the fol-  
23          lowing: “, and \$300,000,000 for each of fiscal years 2020  
24          through 2023”.

1 (b) REPEAL TERMINATION OF GRANTS FOR HIRING  
2 OFFICERS.—

3 (1) IN GENERAL.—Section 1701(i) of the Om-  
4 nibus Crime Control and Safe Streets Act of 1968  
5 (34 U.S.C. 10381(i)) is repealed.

6 (2) CONFORMING AMENDMENT.—Section  
7 1701(j)(1) of the Omnibus Crime Control and Safe  
8 Streets Act of 1968 (34 U.S.C. 10381(j)(1)) is  
9 amended by striking “subsection (i) and”.

10 (c) SCHOOL RESOURCE OFFICER FUNDING.—Section  
11 1704 of the Omnibus Crime Control and Safe Streets Act  
12 of 1968 (34 U.S.C. 10384) is amended—

13 (1) in subsection (c), by striking “\$75,000” and  
14 inserting “\$125,000”; and

15 (2) by adding at the end the following:

16 “(d) SCHOOL RESOURCE OFFICERS SET ASIDE.—  
17 Not less than 30 percent of the amount made available  
18 for hiring and rehiring additional career law enforcement  
19 officers shall be made available for the salaries and bene-  
20 fits of the school resource officers hired pursuant to a  
21 partnership described in section 1701(b)(12).”.
